### **News - Board Announcement**

# **News - Board Chair**



The Board welcomes Naomi as Chair. As a permanent care parent of a child with special needs, living in rural Victoria, and as an Aboriginal descendent, she is well placed to understand the unique challenges faced by marginalised and, at times, isolated families. With leadership roles in corporate recruitment, disability employment and experience in migrant services and various executive governance roles, Naomi's focus will be on enhancing our stakeholder relationships and advocating on behalf of members. During 2021 Naomi has served as PCA Families Deputy Chair and completed ICDA's Diploma in Governance.

The Board thanks outgoing Chair, Meredith Carter. Meredith has been instrumental in the development of two respected research reports commissioned by PCA Families on the importance of supporting permanent care and adoptive families. Under her leadership as Chair there has been a significant increase in funding from the Department of Families, Fairness and Housing to administer our service and programs - Flexible Funding, Homestretch and Better Futures. An increase in the Flexible Funding program available to carers, and the certainty of helpline funding obtained through to June 2024 are also achievements of note. Key advocacy outcomes achieved during this time include the expanded eligibility of Homestretch and Better Futures programs to include permanent care young people. Meredith will remain on the Board to continue sharing her lived experience, extensive governance experience and knowledge of the sector.

# **News - Board Secretary**

PCA Families Board is outsourcing the role of Secretary in recognition of the particular skill set and resources required for a growing organisation like PCA Families. The Board thanks the outgoing Secretary, Chris Lockwood and Jaclyn Letts, who have provided significant support to both the Board and its Executive Committee as a volunteer over the past two years.

# **News - Outgoing Chair**



#### Dear members and friends of PCA Families

You are the heart of PCA Families and the reason we exist. I'd like to thank you all for your support this year - a tough one as we all know for everyone. I hope that PCA Families has been part of what has enabled you and your family to get through it. I know our staff have worked incredibly hard to get the Flexible Funding out to our community and also to develop new and creative ways of delivering support. I especially loved the podcasts this year and that we could offer retreats to some of our families.

#### Proud to highlight the importance of permanency

The whole board is very proud of the increasing profile and attention to the needs of permanent carers that we have been able to achieve in these last few years. In particular it seems there is increased recognition that families who offer permanent care and adoption to children and young people who cannot live with their birth parents are actually performing a role on behalf of the state. These children would otherwise be living in arrangements that are not stable or permanent. The impact on both their life outcomes and on the state itself is increasingly understood to not be good. At the same time the evidence that stable, permanent families deliver positive outcomes is increasingly well known. In that light I'm also really pleased to see that support extended beyond age 18 through Home Stretch, helping to ensure young people can stay in their permanent care families.

#### Grateful for your support

I am really grateful for the support given to current board members including me returned at two elections this year. After four years, I have stepped down as Chair, in what will be my last term on the Board. I am pleased to report that Naomi Colville is the incoming Chair.

#### Keen to promote your priorities

We are keen to take advantage of your creative ideas for strategic advocacy and action. Member engagement will be particularly important to the Board's decisions about how to prioritise the recommendations from the research report Permanence and Stability we recently launched. This is especially important in an election year at both state and federal levels. If you haven't checked out the report and recommendations yet have a look at them here. More advice on ways to contribute will be coming up however please feel free to share your views with any of our staff or board members.

#### And hope you have a relaxing festive season

Finally, I've got fingers crossed that interstate members of my family will make it here for the festive season - our plans last year went completely out the window! I do hope you will be able to catch up with friends and family for fun times without too much stress.

# **News - Children's Vaccinations**

Children aged 5 to 11 will be eligible for COVID-19 vaccinations from 10 January 2022. This includes 5-year-olds attending early childhood education and care services.

The vaccine is one-third of the adult dose and will be delivered at 2 appointments, expected to be 8 weeks apart. The time between the 2 doses can be shortened in special circumstances, such as in an outbreak response or for international travel.

The Victorian Government aims to enable all children aged 5 to 11 to receive at least one vaccine dose before the end of January 2022,

## Click and Connect - 2022 Plans



A reminder that PCA Families has Flexible Funding available to meet the extraordinary needs of children and young people subject to a Permanent Care Order, or where you are receiving DFFH care allowance and have a Family Court Order or Special Needs Adoption Order.

Flexi funds can be used for therapeutic, educational and medical services, to build skills, interests or attachment, to elevate family contact and cultural identity, to offer respite, home medication or other services like whitegoods, one off clothing, estate planning or vehicle needs eg car seats.
